made available for use by scoring program providers and users. This is to allow the correct identification of players for scoring purposes. Information relating to your National Grading Scheme (NGS) grade and master point rank, together with your county of affiliation, will be generally available from the EBU website unless you have chosen for it to be private. EBU members can do this by logging on to My EBU -> Account -> My Details at <u>www.ebu.co.uk/members</u> .						
Your data may be processed by "Bridgewebs" or other organisations that act as Data Processors on our behalf. They may only use it for the specific purposes for which they act as our data processors and they are not free to pass this on to other organisations that are not connected with Hungerford Bridge Club.						
Your personal data is not passed on by us for use by any other third parties whether or not connected with bridge.
