# From Director Anne Landry:

According to ACBL Rules and Regulations, dummy has very specific rights and restrictions. Rights:

- Dummy may give information as to fact or law IN THE PRESENCE OF THE DIRECTOR.
- Dummy may keep count of tricks won and lost; to this end, dummy may:
  - Ask to see a card on the current trick that was turned before he could see it;
  - o Inform declarer that he has turned the card OF THE CURRENT TRICK in the wrong direction.
- Dummy may ask declarer (but not a defender) when he has failed to follow suit to a trick whether he has a card in the suit led.
- Dummy may try to prevent any irregularity by declarer (such as leading from the wrong hand).
- Dummy must play the cards of the dummy as directed by declarer.

# **Restrictions:**

- Unless attention has been drawn to an irregularity by another player, dummy should not initiate a call for the director during the play of the hand.
- Dummy must not participate in the play of the hand; dummy may not communicate anything about the play of the hand to the declarer (such as commenting on a defender's failure to follow suit).
- Dummy may not exchange hands with the declarer.
- Dummy may not leave his seat to watch declarer's play of the hand
- Dummy may not, on his own initiative, look at the face of a card in either defender's hand.
- If, during the play of the hand, Dummy draws attention to a defender's irregularity, there is no rectification and play continues as if no irregularity had occurred.
- Dummy may not play any card until a specific card has been called by the declarer; dummy may not direct the play of any card(s) by pointing at a card, hovering over a card, or actually detaching a card from its position on the table.

### From the Directors' Desk:

It has been brought to my attention that a new player (new to bridge and to our club) has had two experiences at our club that were described as "most unpleasant". Unless a new player asks for your analysis of a hand, PLEASE REFRAIN FROM ANY DISCUSSION AT THE TABLE!! Even if you are addressing your partner, statements such as "If she hadn't led that Ace I never could have made the overtrick" or "they are in a ridiculous contract, this is a good board for us" or "all she had to do was ruff that club before drawing trump" are completely inappropriate. They smack of gloating and are heard as insulting to the opponent. Remember the days when you were first learning the game and recall how intimidating the established pairs could be. The ripple effect of this behavior is that this new player is now telling all of her friends how unpleasant this club is and none of them will now be playing here. Directors will be on the alert to nip these kinds of exchanges in the bud, but we can use help from everyone.
