

COURTESY FIRST!! In this lengthy season of political high drama, let's all remember to be respectful of our fellow players and limit political discussion. And remember that it is a long-standing JSOB policy to avoid wearing political buttons, t-shirts, hats and the like. The bridge table is not a good venue for debates over religion, politics or money!!

AVERAGING, WHAT'S THE BIG DEAL? All games at JSOB are now stratifying the field based on the AVERAGE masterpoints of each pair. If you are playing with a partner in the same strat as you (A with A, B with B, C with C) nothing changes. When you play with a partner out of your strat, the computer will automatically compute the average of your masterpoint totals and place you in that strat. This is a great help to our mentoring pairs who will rarely be required to compete in the A strat when playing with an A mentor. It also helps make the distribution of pairs in each strat more even, thus creating a more equitable field. If you have any questions about how you are being stratified, please do not hesitate to ask your director for an explanation.

PSYCHIC BIDDING Any call that deliberately and grossly misstates either honor strength or suit length is by definition a psych. Psychs that are disruptive to the game warrant disciplinary action. Tactical psychs are an integral part of the game and are perfectly legal but may require an Alert, possibly delayed.

The ACBL Board of Directors has defined types of disruptive bidding that make offenders subject to penalty. Here are some examples:

- Excessive psychic bidding: When three or more psychic actions by members of a partnership have been reported in any one session, a presumption of inappropriate behavior exists and it is up to the players to demonstrate that they are not just horsing around.
- Frivolous psychic bidding: Any psychic action inspired by a spirit of malicious mischief or lack of will to win may be interpreted as frivolous.
- Unsportsmanlike psychic bidding: Action designed to give the opponents an abnormal opportunity to get a
 good score, psychs against pairs or teams in contention, pyschs against inexperienced players and psychs
 used merely to create action at the table are all examples of unsportsmanlike psychic bidding.

Tactical psychs are made to paint a picture in opponents' and partner's minds that will cause them to play you for a holding that you do not have, enabling you to succeed at a contract to which you were inevitably headed. Examples:

- Partner opens 1S. Knowing you are going to end up in 4S, you may bid 2D holding three small diamonds in an attempt to ward off a diamond lead.
- You might cue bid an ace that you don't have on your way to bidding six of a suit, hoping to ward off the lead of that suit.

Frequent use of tactical psychs will develop an implicit partnership agreement which requires an Alert, possibly delayed (at the end of the auction before the opening lead is made).

ACBL requires that clubs regulate the use of uncontrolled psychs. The burden of proof is on the player who makes more than two psychic calls per session to prove that he is not using excessive, frivolous or unsportsmanlike psychic bidding. Disciplinary action will be taken against a player whose bidding does not conform to these regulations. Score adjustments should be made only when the result on the board was affected because the partner, due to previous experience, may have allowed for the psychic call.

JSOB expressly forbids psyching of any kind against C pairs or against mentoring pairs.
