REPORTS:

Dennis Bushman:

Plans for the October Sectional are in place and on schedule.

Remodeling Update:

Construction will continue after JEA installs meters. There is no date set for this as yet. It is hoped that little or no downtime will be necessary after construction resumes.

Pro-Am Game:

Sign-up for the September 26 Pro-Am Game will be initiated shortly by Chairperson Lynn Brown.

Longest Day:

John Orren made a motion that bids be obtained from professional cleaning services to determine whether the club wishes to make a change in this area. Nancy Whitmire seconded. The motion carried unanimously.

Cards:

John Orren made a motion that get well cards and sympathy cards be sent when appropriate in the name of the club. This would be in place of cards that are put out for members to sign. Burton O'Dell seconded. The motion carried unanimously. Barbara Parke is assuming this function.

Cedar Tree:

John Orren moved that the cedar tree in front of the club be removed. Burton O'Dell seconded. The motion carried unanimously.

Web Movement:

Flooring:
