

Jacksonville School of Bridge Board Meeting

The meeting was called to order at 2:22 P.M. by President Nancy Stein

1. **Minutes:** July 20, 2016 minutes approved July 25, 2016 via email.

2. **Bookkeeper:** Denny Bushman reported \$700 profit for August, 2016 and a profit of \$6161.15 for the year to date. \$63,000 is now in the money market.

John Reeve moved that \$30,000 be moved into a 1 year CD maturing 6 months after the other CD. Dane Margol seconded. Motion carried unanimously.

3. **Building Maintenance:** Julie Bradley reported a belt was replaced on the air conditioner and a duct is probably needed where the stain is. However, the 2006 roof replacement warranty from a now defunct roofing company says the sealant needs replacing. The roofer is trying to find a company to honor the 10 year warranty. This may take care of the duct problem.

5. **Comparison of old & new ACBL fees:** Anne Landry reported a 33% increase in ACBL table fees. Board decided not to raise table fees at this time.
6. **Duval School Program:** Burt O'Dell reported 35 students on Tuesday night paid Duval School \$60 to attend. Some are also attending chat bridge. The Tacos & Teams group met at the same time last Tuesday. The two groups enjoyed each other's company participating in the dinner.
