# **Washington Bridge League -- 2021 Annual Meeting Minutes**

### Opening Remarks by President Linda Marshall

Linda expressed her appreciation for the board taking steps to restart faceto-face Thursday evening bridge. Until local conditions improve (re: COVID-19 Delta variant and mask mandate), all efforts have been put on hold.

Linda also recognized Chris Miller as the tremendous force behind the creation and management of the virtual club game.

### Treasurer's Report

Herb described 2020 as a very good year overall, thanks in large part to combining efforts with the NVBA (re: virtual club game). While the A/X game has remained strong, he noted that the 0-20 game has not been active since April 2021.

Herb reported a strong balance sheet: zero debt and \$68,000 in the bank – \$8000 of which was added this year. Looking ahead, the goal is to maintain a financial cushion ahead of the financial challenges we may face when we eventually return to face-to-face bridge.

Since the start of the pandemic, the WBL board approved donating 10% of the profits from our online games to the Capital Area Food Bank – \$3000 in total, at the time of this meeting.

### Questions & Responses, Following Treasurer's Report

Herb responded to questions after his Treasurer's Report. A WBL member asked about trends in unit game attendance. Herb said that it has been going down. At its peak in January 2021, the WBL/NVBA virtual game had 84 tables (30 in A/X, 18 in under 2500, 22 in 499ers, 10 in 199ers, and 4 in 0-20). At present, it is now averaging 40-50s tables. For example, at the most recent game, just before Labor Day, Herb reported there were 20 tables in A/X, 9 in under 2500, 8 in 499ers, and 7 in 199ers.

In response to a question on whether "BBO" is considered an expense in the financial statement, Herb stated that WBL receives payments directly from ACBL. BBO collects entry fees directly from participants ranging from \$5-\$7 depending on the type of game. ACBL charges a sanction fee of \$1 per table or \$5 per table (for a special game). BBO has been charging 3.5% for their credit card fee as well as a 20% fee for hosting the virtual game (which includes access to virtual club directors, if necessary).
